Getting or spreading coronavirus by not washing hands or not washing them adequately	Players, Matchday Officials, Club Officials, Volunteers, Supporters, Press & Media	<p>Providing Water, Soap and Drying facilities at wash stations.</p> <p>Providing information on how to wash hands properly and display posters.</p> <p>Providing hand sanitiser for the occasions when people can't wash their hands. (There are numerous sanitiser points located around the stadium)</p>	<p>Stewards and Club Officials to monitor and ensure controls are being followed.</p> <p>Soap and Sanitisers are monitored and replenished when required.</p>
Getting or spreading coronavirus in common use high traffic areas such as toilet facilities, entry/exit points to facilities, changing rooms and other communal areas	Players, Matchday Officials, Club Officials, Volunteers, Supporters, Press & Media	<p>One-way system has been put in place to control the flow of people in 'pinch point' areas.</p> <p>Facemasks to be worn in all indoor areas (turnstiles, clubhouse, changing rooms).</p> <p>Floor markers and signage in place to encourage and remind importance of social distancing.</p> <p>High touch points are cleaned on a regular basis.</p> <p>'Staggered' use of changing rooms is enforced. The numbers of occupants in the changing rooms is limited.</p> <p>**AS OF NOVEMBER 2020 – THE CLUBHOUSE IS NOW CLOSED FOR ALL FOOD & BEVERAGE OPERATIONS. THE ONLY FACILITIES OPEN ARE THE TOILET FACILITIES. ** (Risk Assessment to be updated once these guidelines are changed)</p>	<p>Stewards and Club Officials to monitor and ensure controls are being followed.</p> <p>The stadium is thoroughly checked before opening to ensure all signage and markings are in place.</p> <p>The stadium is thoroughly checked after use to ensure all signage and markings are in place and to replenish any soap and sanitisers if required.</p>

<p>Getting or spreading coronavirus through people living together and/or travelling to the club together</p>	<p>Players, Matchday Officials, Club Officials, Volunteers, Supporters, Press & Media</p>	<p>Identify people who live together and group them into a bubble.</p> <p>Identify people who travel to the club together and group them into a bubble (the players travel together based on where they live).</p>	<p>Re-enforce that these bubbles are maintained with the committee and also coaching staff to ensure the players remain in the same bubbles.</p>
<p>Getting or spreading coronavirus by not cleaning surfaces, equipment and workstations</p>	<p>Players, Matchday Officials, Club Officials, Volunteers, Supporters, Press & Media</p>	<p>High touch points are cleaned on a regular basis.</p> <p>Training has been given by the Covid-19 officer to the committee and volunteers on safe cleaning and best practice.</p> <p>Avoid sharing any equipment.</p> <p>Encourage contactless card payments rather than chip and pin or cash.</p> <p>Doors propped open to avoid any unnecessary touch points.</p>	<p>Checklist completed to show cleaning has been carried out.</p> <p>Each 'department' has their own card machine etc. Nobody shares equipment.</p> <p>Club Social Media Platforms and website advise of preferred use of contactless payments.</p>
<p>Contracting or spreading the virus by not social distancing</p>	<p>Players, Matchday Officials, Club Officials, Volunteers, Supporters, Press & Media</p>	<p>'Staggered' use of changing rooms is enforced. The numbers of occupants in the changing rooms is limited.</p> <p>Floor markers and signage in place to encourage and remind importance of social distancing.</p> <p>One-way system has been put in place to control the flow of people in 'pinch point' areas.</p> <p>Limited capacity of a maximum of 400 – as per FA Guidelines for Step Four Non-League.</p> <p>Facemasks to be worn in all indoor areas (turnstile, clubhouse, changing rooms).</p>	<p>Stewards and Club Officials to monitor and ensure controls are being followed.</p>
